**ENTRIES:** Double entries: Not accepted. Use 2010 USEA Entry Form. BN competitors who are not USEA members must pay extra \$25 with entry. If oversubscribed, priority to USEA members. \$35 will be charged for any Lost pinny.

**REFUNDS:** Before C.D.-less \$25 non-refundable office fee; After C.D.-Less \$25 ONLY if place can be filled from wait list. Stabling-In full. No refunds after July 24. Only fax, mail or email withdrawals will be accepted (no phone withdrawals). Competition cancellation-Stabling only. Neg. Coggins required within 12 months for all horses. Changes after C.D.-\$25/change. USEF membership cards required for I & P (owner, trainer & rider).

**ADDITIONAL INFORMATION:** a) Unstabled Horses must pay \$20 Horse Park trailer-in fee. b) No changes to entry after closing date, unless allowed by the secretary. Each change will be \$ 25 per change. Absolutely no changes will be accepted after July 15th. Include e-mail address on entry. c) Intermediate and Prelim riders please enclose copy of USEF membership Card.

**DRESSAGE AND ARENAS:** Intermediate - Test B Large Arena; Preliminary - Test C, Large Arena; Training - Test B, Small Arena; Novice - Test B, Small Arena; Beginner Novice - Test B, Small Arena. Arenas are all-weather footing composed of sand and screenings for dressage and stadium.

**STABLING:** 275 permanent stalls on grounds, \$55 / night. Stall doors only provided. Bedding available for purchase. Additional info from secretary. **NO STRAW ALLOWED.**

**CROSS COUNTRY:** Lengths and speeds for levels: I- 3200 m @ 550 mpm; P-2700 m @ 520 mpm. All T-2400 m @ 420 mpm. All N-2000 m @ 350 mpm. BN-1900 m @ 350 mpm. Terrain: Rolling, great footing. All courses:I/ P-Moderate course with options. T/N/BN For horses with

some experience at these levels. \*Water jump at all levels.
