**ENTRIES/FEES:** a) \$30.00 per class; b) Make checks payable to: Horse Park of NJ / all major credit cards are accepted; c) Refund Policy: Before closing date less \$20 handling fee. NO REFUNDS AFTER CLOSING DATE; including acts of God, inclement weather, or other emergencies d) Negative coggins within 24 months IN-STATE. Negative coggins within 12 months out-of-state. Coggins MUST accompany entry; e) Entries must be received by closing date. Entries postmarked, but received after the closing date are subject to a \$10.00 post-entry fee, if space permits; f) Non-negotiable check will void entry and incur a \$50.00 fee.

**WARM-UP:** Ride times will be scheduled as to allow warm-up in the indoor arena.

**STABLING FEES:** Day stalls available - \$35.00 Pre-ordered shavings \$7/bag; \$8/bag on site .NO STRAW BEDDING! The Horse Park will charge \$10.00 per stall additional clean up fee if straw bedding is used.

**AWARDS:** Prizes and six ribbons per class.

**ARENA:** Shows may be held in either a small and large arena in the Indoor arena – soil composite.

**RIDE TIMES:** Wednesday evening prior to show, at [www.horseparkofnewjersey.com](http://www.horseparkofnewjersey.com), and will be emailed if a legible email address is provided on entry form.

**OTHER:** Food and beverages available for purchase on premises. All dogs MUST be on a leash at all times! Please call secretary for info on schooling horses. Please state on entry form any special considerations; i.e. trailering with other competitors, multiple horses entered, etc.

**SERIES INFO:** Special awards for competitors that compete in at least three of the five shows and have the highest combined scores. Awards will be given for each division Jr. and Sr. provided there were at least three entries in each (Intro, Training, First, Second & Above, and USEA Eventing)
